## ROBIN L. HIRTLE, KRISTIN M. MOW AND BENJAMIN C. MOW SUPPORT FOR MOTION TO CONSOLIDATE EVIDENTIARY HEARINGS

On March 15, 2011 FairwindCT, Inc. ("Fairwind"), Susan Wagner and Stella and

Michael Somers objected to procedures established by the Siting Council regarding the sequence of evidentiary proceedings for these two petitions — beginning the evidentiary hearing for both petitions with cross examination only as related to Petition No. 983; then at a later date commencing cross examination for Petition No. 984. In their filing, Fairwind, Wagner and the Somers set out the bases of their objections (inefficiency, parties and witnesses to return; additional expense for all parties, including petitioner; prejudice to citizens; notice requirements; etc.)

Fairwind, Wagner and the Somers then moved to consolidate the evidentiary hearings for both petitions, noting, accurately, that Robin L. Hirtle has no opposition to doing so. They requested the evidentiary hearings for both petitions be consolidated, which appears to have no prejudicial effect either upon BNE or upon the Council and should not affect the deadlines for each petition, but rather should alleviate some of the time requirements the Council must meet. This is to advise the Siting Council, petitioner and all parties and intervenors that Robin L. Hirtle, Party to Petition number 983; and Kristin and Benjamin Mow, Parties to Petitions number 983 and 984, hereby join in the objection to the afore-mentioned hearing procedure and join in with Fairwind, Wagner and the Somers in moving the Council consolidate the evidentiary hearings of Petition Nos. 983 and 984 in accordance with the Council's hearing notices and to promote efficiency and due process.
