This is a petition for party status in the Petition of BNE Inc. for a Declaratory Ruling for the Location, Construction and Operation of a 4.8 MW Wind Renewable Generating Project on Flagg Hill Road in Colebrook, Connecticut "Wind South" dated December 6, 2010 and the Petition of BNE Energy Inc. for a Declaratory Ruling on Winsted- Road in Colebrook, Connecticut "Wind Colebrook North" dated December 13, 2010

1. Manner in which proposed party claims to be substantially and specifically affected

I'm a resident of Colebrook CT. I'm an abutting property owner my property is 1300ft. from the proposed location of the (Wind Colebrook South) facility. My property is located east of the proposed facility and is identified in the Perimeter Survey at page 5 of Exhibit F Petition 983 Abutters map. For 23 years I've enjoyed gardening, hiking, x country skiing and bird watching from this location. The proposed facility will negatively impact the enjoyment of my property and the value of my property. The proposed Facility also poses a threat to the health and safety of my family.

2. Contention of the petitioner:

In 1987 my husband got a great job with CBT Bank. His territory was Northwest corner of Connecticut. We we're living in Northborough, Ma. I was pregnant with our first child and had to spend numerous days and hours commuting to Connecticut to look for a new house. When we found a new house at 28 Flagg Hill Rd Colebrook, we we're elated, it was on a dead end road which meant very little traffic. It abutted the Algonquin State Forrest, which meant no one would build next to us. It was private and quiet. We also loved the quaintness and charm of the Town of

Colebrook. I've lived there for 23 years, I raised two children, planted numerous gardens. I work from my studio there.

I take umbrage in the Town of Colebrook's sequence of events which led to the erection of BNE's meteorological tower. On November 10, 2008, BNE applied to the Planning & Zoning Board for the meteorological tower. On November 24, 2008, this proposal was approved. In December of 2008 my neighbors and I noticed logging trucks emerging from 29 Flagg Hill Rd. It wasn't till this time that myself, my neighbors & abutters, knew of BNE's proposal. On January 26, 2009 an appeal was filed against the ZEO for signing the zoning permit for the meteorological tower by Steven King, an abutter on Flagg Hill Rd. February 4, the appeal was denied by the Zoning Board of Appeals. He then sued the Town of Colebrook & BNE, but for unknown reasons he dropped the suit & sold his property to BNE.

I have read chronicles by Dr. Nina Pierpont, "Wind Turbine Syndrome" and many others which states the ill effects of wind projects of this magnitude; sleep deprivation, dizziness, tinnitus, memory and concentration problems, nausea, headaches, vertigo, ear pressure or pain irritability, fatigue, racing heartbeats, visual blurring and panic episodes. These symptoms are attributed to the noise as little as 32.5 dba, vibration, and shadow flicker from industrial turbines. The elderly and children are the most vulnerable to these effects. This obviously concerns me but especially because I'm expecting my first grandchild in May of this year.

Vestas, which is a leading manufacturer of industrial wind turbines states to their employees not to approach a moving turbine closer than 1300ft unless absolutely necessary without a hard hat. Will I and others be living in a hardhat zone? The UK has changed their setbacks to 1.93 kilometers (1.5 miles).

I'm concerned about the health and safety of myself and my family, and also the value of my home. I'm concerned about impact on the aesthetics and future of the town and for the negative impact on the wildlife.

3. Relief sought by the petitioner:

I ask the Siting Council to deny 983 and 984 in their entirety. I further ask the Council to impose a moratorium on all wind generation projects until appropriate laws and regulations may put in place by the State, the Council and local regulatory bodies. I ask that my matters of concern are addressed by unbiased research. I ask that "Wind Turbine" Syndrome and public safety be considered a serious matter.

4. Statutory or other authority therefore; and

I'm entitled to party status in this proceeding pursuant to Sections 4-177a, 16-50l and 16-50n 22a-19, 22a-20 of the Connecticut General Statutes and Sections 16-50j-13 through 17 of the Regulations of the Connecticut Siting Council.

5. Nature of evidence that the petitioner intends to present:

I will present testimony regarding the negative impact the proposed facility will have on our health and safety, right to use and enjoy my property and property value. I will present the


studies, surveys and expert opinions on the effects of 4.8MW Turbines on people, wildlife and property values.

6. Other comments for the Siting Council's consideration:

I ask that the Council hold public hearings on BNE's petitions for declaratory rulings in Colebrook (or one the surrounding towns with a building large to accommodate such a hearing), so that local residents will have the opportunity to voice their opinion on the proposed facilities. Many residents do not have the time or means to participate in this proceeding as parties and travel to New Britain. They also deserve to be heard on this important issue.
