

Pursuant to the 2005 State building Code supplement to the IBC 2003 Section 109 *Inspections* the following is a report documenting the construction which has been completed to date at the above-mentioned site. The following report documents the visual inspection from ground level of completed construction for general conformance with <u>T-Mobile L700 Alteration</u> construction drawings prepared by Hudson Design Group, LLC, 1600 Osgood Street, Building 20 North, Suite 3090, North Andover, MA 01845 revised through 09/04/15 REV1, sealed by Daniel P. Hamm, III CT Reg. No. 24178.

The following items have been completed:

- (3) Three T-Mobile L700 antennas (Typ. of 1 per sector, total of 3) have been installed on new antenna pipes secured to the existing antenna frame and new reinforcement kit in general conformance with construction drawings.
- 2) (3) Three T-Mobile RRUs (Typ. of 1 per sector) were installed mounted behind the L700 T-Mobile antennas on the new pipe mount.
- 3) (1) One square (dish) antenna (Alpha Sector) has been relocated adjacent to the L700 antenna. The dish antenna pipe mount has been secured to the existing antenna mount cross pipe. We recommend this antenna be monitored for rotation as routine maintenance and connected to the lower reinforcement cross pipe as required.

- 4) Installed the antenna mount reinforcement kit that appears to be a Commscope VSR-MS-B with cross pipe below the existing t-arm mount in general conformance to plans. The lower mount location differs from the location above the existing mount shown on plans, however this configuration is acceptable.
- 5) There were no proposed changes to the existing electrical in the construction drawings, however our office is of the understanding that any required electrical work was performed by a licensed electrician and inspected by those having jurisdiction as required.

The comments in this field report are a record of observations made on site. If there are any errors or omissions please notify ProTerra Design Group, LLC in writing or all comments and all parties shall consider this report factual and acceptable.




P-1: T-Mobile antennas
