Dear Catherine Conklin:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on March 2, 2023.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the request. Page 1 of the exempt modification request states the proposed generator would be installed "...within the existing grade-level fenced compound..." however, based on Sheet A-1 of the site plans provided in Attachment 1 of the request, AT&T is proposing to install the generator outside of the fenced enclosure for its equipment. On February 28, 2014, the Council issued a memo requesting a depiction or description of the leased area for the subject site be included with the site plan for exempt modification requests ([20140228EMTSLeasememofeb20142pdf.pdf \(ct.gov\)](http://portal.ct.gov/20140228EMTSLeasememofeb20142pdf.pdf)). The exempt modification request does not include a depiction of the lease area that designates the site boundaries. Therefore, it is unclear whether the generator AT&T intends to install will require the extension of the site boundaries.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that AT&T provide revised site plans that include a depiction of the proposed generator within the lease area that designates the site boundaries on or before April 21, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to April 21, 2023.

Please provide an electronic version and one hard copy of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
