RE: MetroPCS Notification Regarding Connecticut Siting Council Approval

Dear Mr. Caruso,

The purpose of this letter is to notify the Connecticut Siting Council ("CSC") that MetroPCS New York, LLC ("MetroPCS") would like to make modifications to its existing wireless communication facilities at each of the site locations listed below. MetroPCS intends to install one (1) radio cabinet and one (1) new 120v / 60 amp electrical breaker and applicable conduits all within the existing MetroPCS lease area/equipment platform.

For all of the sites listed below, MetroPCS has obtained CSC's approval for the installation of either three (3) or four (4) wireless communication cabinets within MetroPCS' lease area/equipment platform. Currently, each location has only two (2) wireless equipment cabinets installed. This addition of the third (3rd) cabinet will not increase MetroPCS' existing lease area.
