Dear Mr. Sagristano:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on December 7, 2017.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

The structural analysis report states "The **Sprint** standoff mounts will be analyzed under a separate report." Therefore, it is unclear whether the standoff mounts are included or not included with the structural analysis. Therefore, the exempt modification request is incomplete at this time.

The Council recommends that Cherundolo Consulting provide one copy of the separate report for Sprint standoff mounts, stamped and signed by a professional engineer duly licensed in the State of Connecticut, on or before January 9, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to January 9, 2018.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
