So when I downloaded the "Statewide Comprehensive Database", it shows Polly Lane in Bozrah, guyed lattice, 185', with Sprint (150'), Cingular (192'), Verizon (138')

When I downloaded the Database of CSC Approved Telecommunications Sites, it also shows Polly Lane. I'm not sure what else you are looking for on their website, but I would think that the CSC has this record somewhere.

I will look again, but without a specific year, and more detail on what a "facility" means, this is a needle in a haystack and I am limited on hours in Bozrah (as I serve 4 towns total).
