The Connecticut Light and Power Company ("CL&P") doing business as Eversource Energy ("Eversource") received acknowledgement from the Connecticut Siting Council ("Council") on November 7, 2016 that Eversource's proposed modification of the Branford Substation would comply with the exempt modification criteria in Section 16-50j-57 of the Regulations of Connecticut State Agencies.
