On March 18, 2022 the Connecticut Siting Council (the “Council”) granted The United Illuminating Company (“UI” or the “Company”) an extension of time until April 20, 2023 to submit a notice of completion of construction concerning replacement of existing bus insulators with high strength insulators and the replacement of existing steel switch columns with stronger members at UI’s Congress substation in Bridgeport, Connecticut (the “Project”).

The Company apologizes for not completing the project by the April 20, 2023 deadline and for failing to further extend the deadline for the filing of the notice regarding the completion of construction.
