

Dear Mr. Whalen:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on June 13, 2017.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, "no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies..."

Staff has reviewed this tower share request for completeness and has identified deficiencies in the filing as it does not include a letter from the owner of the facility that the owner agrees to the proposed shared use of the facility, and the Structural Analysis report included with the filing refers to the 2005 Connecticut State Building Code rather than the updated 2016 Connecticut State Building Code.

Therefore, the tower share request is incomplete at this time. The Council recommends that Centerline Communications file the required letter from the owner of the facility stating agreement to the proposed shared use of the facility, and a new structural analysis report using the 2016 Connecticut State Building Code on or before June 30, 2017. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to June 30, 2017.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
