5. City of Bristol Building Permit #: B-22-468.


Based upon the aforementioned, the complete Verizon Wireless installation is in apparent conformance with the design documents and have been seemingly satisfactorily completed.

Interim reports submitted prior to this final report form a basis for and are to be considered an integral part of this final report.


