Dear Mr. Perkowski:

The Connecticut Siting Council (Council) hereby denies your request to modify the above-referenced existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

This exempt modification request was submitted to the Council on August 1, 2019. Council staff reviewed this request for completeness and had identified several deficiencies that were described in a notice of incompleteness letter to the requesting entity dated August 6, 2019. The notice of incompleteness recommended that Airosmith Development provide clarification on the proposed mount modification, the corresponding amended document, a Structural Analysis signed and stamped by a Professional Engineer duly licensed in the State of Connecticut and the Mount Analysis referenced in the letter, on or before September 6, 2019.

The Council also approved a 30-day extension of time to submit the required documentation by October 4, 2019, and a second extension of time to submit the required documentation by November 4, 2019.

To date, the Council has not received the requested information.

Thus, the proposed modification is not in compliance with the exemption criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies and is hereby denied.

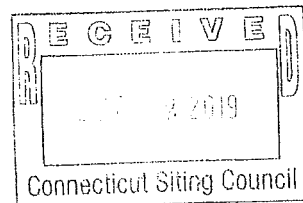

Dear Mr. Perkowski:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on August 1, 2019.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the Construction Drawings (CD) prepared by Infinigy Engineering dated June 11, 2019, and the Structural Analysis Report (SA) prepared by American Tower Corporation dated May 21, 2019. Sheet A-3 of the CD proposes a replacement of the existing T-arm mount with a new Platform mount – Site Prod RMQP-NP; however, the SA does not account for this mount modification. Also, the SA is not stamped by a Professional Engineer duly licensed in the State of Connecticut or the digital signature in the electronic copy is not visible.

If the revised SA exceeds 101%, a new letter from the State Building Inspector is required.

In addition, a structural note on sheet A-2 of the CD references a Mount Analysis (MA) prepared by Infinigy Engineering dated January 10, 2019. This MA is not provided with the request.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Arosmith Development provide clarification on the proposed mount modification, the corresponding amended document, a SA signed and stamped by a Professional Engineer duly licensed in the State of Connecticut and the MA referenced above, on or before September 6, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to September 6, 2019. **Please provide an electronic version and one hard copy of the response for the incomplete request to be rendered complete and processed.**

This notice of incompleteness shall have the effect of rolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
