RE: TS-CING-018-191017 - New Cingular Wireless PCS, LLC (AT&T) request for an order to approve tower sharing at an existing telecommunications facility located at 39 Carmen Hill Road, Brookfield, Connecticut.

Dear Ms. Motel:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on October 17, 2019.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, "no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies..."

Staff has reviewed this tower share request for completeness and has identified the following deficiencies:

- No mount analysis has been included with the request for tower sharing; therefore, it is unclear whether additional reinforcements would be required for the antenna mount, which would alter the proposed loading on the structure and require an updated structural analysis report;
- The request lacks documentation of the original facility approval and any conditions of such approval or correspondence with the Town of Brookfield stating that the town no longer retains records of its decision; and
- 3. A property card and parcel map for the underlying property has not been provided with the request.

Therefore, the tower share request is incomplete at this time. The Council recommends that Cuddy+Feder, LLP provide a mount analysis for the proposed modification that is stamped and signed by a professional engineer duly licensed in the State of Connecticut, documentation showing the original facility approval with conditions, if any, or correspondence with the Town stating that there are no records of the original facility approval, and a property card and parcel map for the underlying property, on or before November 22, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to November 22, 2019. Please provide an electronic version and one hard copy of the requested information for the incomplete tower share request to be rendered complete and processed. Please include the Council's tower share identification number referenced above with the submittal.



This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
