Request for Amendment to the Order Approving Shared Use of an Approved Fire

Department Tower

Premises: 719 George Washington Turnpike

Burlington, Connecticut TS-CING-020-050913

Dear Chairman Katz and Members of the Council:

On behalf of New Cingular Wireless PCS, LLC ("Cingular"), we respectfully request an amendment to the above referenced order approving the shared use of the Burlington Fire Department municipal replacement tower that was issued by the Siting Council on September 28, 2005. As fully set forth herein and detailed in the accompanying drawings, the replacement communications tower was relocated on the Burlington Fire Department premises. As such, Cingular is seeking an amendment to the September 28, 2005 order approving the shared use of the replacement tower for the relocation of the facility.

As shown on the enclosed drawings prepared by Dewberry-Goodkind, Inc. and dated December 27, 2005, the replacement monopole was relocated approximately 40 feet northeast of the existing lattice tower. The prior location of the replacement tower was approximately 90 feet to the southwest of the existing lattice tower. The replacement monopole and the equipment compound were relocated pursuant to an agreement between the Town of Burlington and the

State Department of Health. Due to the presence of a well on the Fire Department premises, the replacement tower and equipment compound were relocated more than 200 feet from the existing well. Amended site plan approval for the relocation of the replacement tower and equipment shelter was issued by the Burlington Planning and Zoning Commission on January 11, 2006.

The relocation of the replacement monopole and equipment compound on the premises is the only change from the September 28, 2005 order approving the shared use of the Fire Department facility. All other factors supporting the September 28, 2005 order included in Cingular's September 13, 2005 request are the same. The relocation will have an insignificant visual impact and will not increase the noise levels at the existing facility by six decibels or more. Further, the relocation will not impact the total radio frequency results provided in the September 13, 2005 request. (A copy of the September 13, 2006 request is annexed hereto in Exhibit B). As such, the requested amendment to the order approving the shared use of the Burlington Fire Department municipal replacement tower is technically, legally, environmentally and economically feasible and meets public safety concerns.

Based on the information contained herein and in the accompanying materials, Cingular respectfully submits that approval of its requested amendment is warranted and complies with the criteria of Connecticut General Statutes §16-50aa promoting the shared use of tower facilities. Thank you for your consideration of the foregoing. Should any Members of the Council or Staff have questions regarding this information, please do not hesitate to contact me.
