Dear Mr. Robinson:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on April 16, 2021.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the request. The Mount Analysis (MA) prepared by GDP Engineering dated February 4, 2021, does not specify a replacement of the antenna mount consistent with the Structural Analysis (SA) and Construction Drawings (CD) both prepared by B+T Group and dated February 19, 2021 and March 24, 2021, respectively, as Platform Mount LP 602-1.

The Council recommends that Crown Castle provide a SA and CD consistent with the MA or a revised MA that is consistent with the SA and CD, on or before June 1, 2021. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to June 1, 2021. Please provide an electronic version of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
