To the best of my information, knowledge and belief, the Special Inspections required for this project, and itemized in the *Statement of Special Inspections* submitted for permit, have been performed and all discovered discrepancies have been reported and resolved.

Representatives of Centerline Communications, LLC performed the Final Inspections after the construction of the telecommunications facility at the above-referenced address. The Final Inspection was performed on June 22, 2021.
