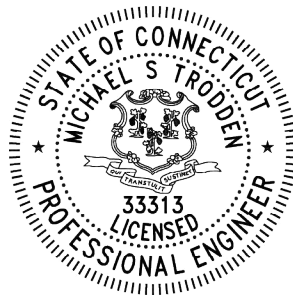
- Field observations conducted by others 01/2024 for the completed modifications, which determined that all modifications were installed in compliance with the recommendations of the aforementioned design documents; and
