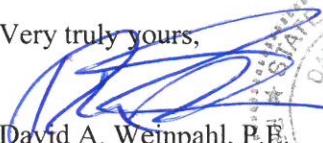
We are providing this letter of compliance with regard to the above referenced project. The following are the basis for substantiating compliance with this modification:

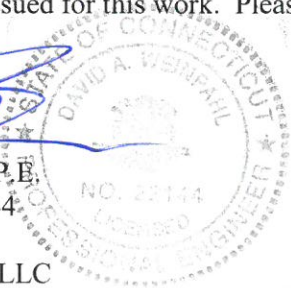
- Construction Drawings by On Air Engineering dated 10-30-19 V1

- Mount Structural Modification Report by Paul J. Ford & Company dated 05-20-19

Verizon's facility modification is described in detail within the above referenced Construction Drawings as it pertains to Verizon antenna, RRH, OVP and cabling upgrades. The Mount Structural Modification Report also detailed mount reinforcements required for each antenna frame, consisting of "stabilizer kits" and pipe mast replacements, both of which have been completed. A third item involving the rotation of the Beta sector frame was not performed, however, that is not a structurally critical element, and we take no exception to the frame remaining as it originally existed.

The work under this contract has been reviewed and found, to the Engineer's best knowledge, information and belief, to be completed in general compliance with the referenced documents and in conformance with the building permit issued for this work.
