Cullen Morgan sent in a cancellation notice for this Exempt Mod earlier this week. Just this morning, Centerline was notified by T-Mobile that they have reactivated the funding for the project and is aiming to build in Fall 2023.

Therefore, if possible and if this email makes it in time, **T-Mobile would like to recall the cancellation notice and instead send in an extension request.** Cullen will prepare a formal letter to reply all to this email chain.

T-Mobile put the funding on hold for this project a few months ago and we held out cancelling until just now as the expiration was quickly approaching. We were hopeful that it would be re-funded. Murphy's Law that they unexpectedly re-funded right after we decided to notify the CSC.

We apologize for any confusion and if we are too late, please let us know and we will file a new application with the same plans and SOW.
