The Connecticut Siting Council (Council) is in receipt of your letter dated October 20, 2020, submitted on behalf of T-Mobile, requesting an extension of time to submit a notice of completion of construction for the above-referenced exempt modification.

The Council hereby denies the request for an extension of time to modify the facility. Pursuant to Conditions 5 and 6 of the Council's decision letter dated September 9, 2019 for the exempt modification request, the Council's approval of the modification expired on September 9, 2020 and the applicant did not submit a request for an extension at least 60 days prior to the expiration.

Any modifications to this facility will require explicit notice to the Council pursuant to Regulations of Connecticut State Agencies Section 16-50j-73 and a filing fee.
