Dear Mr. Rinebold:

Please accept this letter in response to the Council's request, dated June 12, 1998, for information pertaining to Springwich Cellular Limited Partnership's (SCLP's) possible need for a permanent facility which would be located near the Tournament Players Club (TPC) in Cromwell.

Currently SCLP provides adequate cellular coverage to the TPC area for existing customer demand from our Rocky Hill and Portland cell sites, which are within four miles of the TPC.

SCLP installed a temporary facility to meet the increased calling capacity generated by the large attendance at the GHO, and to continue the level of service expected by our customers. This temporary cell site sufficiently met the need for the increased capacity generated during the time of the tournament. After the conclusion of the tournament our existing sites adequately provide the quality service needed for our customers.

Because of the reasons listed above, SCLP does not have any future plans to install a permanent site at or near the GHO.

While the Council is not advocating that a permanent facility should be developed at this location, the Council does seek additional information to describe how this area can be served when the temporary facility is not in operation.

Dear Mr. van Wilgen:

At a public meeting held on June 11, 1998, the Connecticut Siting Council (Council) acknowledged your notice of intent to install a temporary cellular telephone facility for use at the Greater Hartford Open at River Highlands in Cromwell, Connecticut, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

The proposed temporary facility is to be established as specified in your notice dated June 1, 1998. The temporary facility is in compliance with the exception criteria in Section 16-50j-72 (d) of the Regulations of Connecticut State Agencies as temporary use of a facility to cover an event of statewide significance. This temporary facility has been carefully modeled to ensure that radio frequency emissions are conservatively below State and federal standards applicable to the frequency used on this tower. Any additional change to this facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Science and Technology, Bulletin No. 65. Any deviation from this format may result in the Council implementing enforcement proceedings pursuant to General Statutes § 16-50u including, without limitation, imposition of expenses resulting from such failure and of civil penalties in an amount not less than one thousand dollars per day for each day of construction or operation in material violation.

Dear Mr. Rinebold:

Springwich Cellular Limited Partnership ("SCLP") plans to install a temporary cell site for use at the Canon Greater Hartford Open (the "GHO") at the River Highlands Country Club in Cromwell. Please accept this letter as notification, pursuant to R.C.S.A. Section 16-50j-73, of construction which constitutes an exempt modification pursuant to R.C.S.A. Section 16-50j-72(d). In compliance with R.C.S.A. Section 16-50j-73, a copy of this letter is being sent to the First Selectman of Cromwell.

The planned temporary cell site meets the criteria set forth in R.C.S.A. Section 16-50j-72(d) for temporary cellular service for events of statewide significance. The site is necessary to accommodate communication needs for the GHO and the surrounding area. The temporary cell site will be placed on property owned by Connecticut Light and Power ("CL&P") on the easterly side of Route 99 in the Town of Cromwell, adjacent to River Highlands. This property will also be used by other communication companies to house television satellite dishes for the television coverage of the GHO. The site will be installed on or about June 25 and removed on or about July 6, 1998.

The temporary cell site consists of a 12' x 16' equipment shelter on a trailer and a 50' telephone pole. Two ASP 952 omnidirectional whip antennas approximately 13' long will be mounted on small sidearms near the top of the pole, one antenna per each sidearm. These antennas will extend above the top of the pole by approximately 10'.

The total radio frequency electromagnetic radiation power density, measured at the tower base, will not be at a level at or above the ANSI standard. A "worst-case" calculation for a point at the base of the temporary cell site indicated that SCLP's temporary operations would result in a power density of  $0.3019 \text{ mW/cm}^2$ . The power density level is 51.5 % of the ANSI standard for uncontrolled environments at cellular frequencies of approximately  $.5867 \text{ mW/cm}^2$ .

SCLP respectfully requests that the Council approve the planned temporary cell site at the GHO pursuant to R.C.S.A. Section 16-50j-72(d)(2).


