Dear Ms. Bachman:

On May 29, 2014, the Siting Council acknowledged receipt of Cellco's notice of intent to modify its telecommunications facility at 160 West Street in Cromwell, Connecticut. Due to delays in its antenna modification program and shifting budget priorities, Cellco has not been able to complete the approved antenna modifications at this site. The work is currently scheduled for completion in 2016. We will not, therefore, be able to provide the Council with the required "construction complete" notice by the May 28, 2015 deadline, and request an extension of one (1) year to comply with this requirement.
