On April 20, 2020, the Siting Council acknowledged receipt of Cellco's notice of intent to modify its existing telecommunications facility at 48 Newtown Road in Danbury, Connecticut. Cellco's modifications involved the replacement of antennas and installation of remote radio heads on the existing tower. Construction of these modifications is now complete.
