Dear Executive Director Bachman:

I am writing on behalf of New Cingular Wireless PCS, LLC ("AT&T"), and in furtherance of the Council's March 6, 2014 order approving AT&T's shared use of the tower facility located at 52 Stadley Rough Road, Danbury, CT.

We were recently advised that AT&T has reduced the size of its equipment shelter from 11'-5" x 24' in size to 11'-5" x 16' in size and has eliminated its backup generator for the time being. AT&T and SBA have agreed on the revised smaller shelter size and the removal of AT&T's generator from the plan for construction. Enclosed is a revised Drawing Sheet C-1 prepared by Dewberry for your records.

Since the changes to the AT&T facility are to install a smaller shelter and not to install the generator, an amended tower sharing approval from the Council does not appear to be required. We did, nevertheless, want to file an updated plan with the Council and confirm our interpretation of the tower sharing approval issued for this project. Additionally, we respectfully request an extension of time for the construction of AT&T's Facility.

Should any further Council filing or approval be required, please let us know and we will further coordinate with your agency, AT&T and SBA. Thank you for your continued assistance and understanding in this matter.


