The following are the basis for substantiating compliance with the tower modification documents prepared by On-Air Engineering, LLC:

- Review of Paul J. Ford & Company Structural Engineers' Structural Analysis (project #37515-1078.003.7805) dated 5/28/15;
- Review of On-Air Engineering, LLC's Construction Drawings dated 8/1/15;
- Review of Tower Engineering Professional's Modification Inspection Report (TEP project #25562.32675) dated 3/1/16; and
- Field Observations by APT personnel on 11/22/16 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the aforementioned structural analysis.
