We are providing this "Tower Modification Certification" with regard to the structural components at the above referenced project.

The following are the basis for substantiating compliance with the tower modification documents prepared by FDH Velocitel (FDH Project Number: 15BTSN1400):

- Review of the FDH's Structural Analysis dated 06/24/2015.
- Review of Verizon's East Granby 2 CT RF Sheet
- Field observations by Centek Engineering personnel on 07/26/16 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the aforementioned structural analysis report.

The Structural Analysis prepared by FDH demonstrates the tower will not exceed 100 percent of the post construction structural rating. The work under this Contract has been reviewed and found, to the Engineer's best knowledge, information and belief, to be completed in general compliance with the documents referenced above. This certification is not a review of the adequacy or effectiveness of the modification/reinforcement solution.
