Sprint Spectrum, LP ("Sprint") currently maintains wireless telecommunications antennas at the 94-foot level on an existing 98-foot tower at the above-referenced address. The tower is owned by Crown Castle. Sprint's proposed work does not involve any antenna or tower work. Sprint intends to install 1 ground based RRH cabinet and 1 ground based fiber junction box to a new proposed wooden H frame. All of the proposed work is contained within the existing fenced area. Please refer to the attached drawings for site plans prepared by Infinigy Engineering.

Please accept this letter as notification pursuant to R.C.S.A. § 16-50j-73, for construction that constitutes an exempt modification pursuant to R.C.S.A. § 16-50j-72(b)(2). In accordance with R.C.S.A. § 16-50j-73, a copy of this letter is being sent to James M. Hayden, First Selectman/Mayor of the City of East Granby. A copy of this letter is also being sent to Galasso Holdings, LLC, the owner of the property on which the tower is located.

The planned modifications to the facility fall squarely within those activities explicitly provided for in R.C.S.A. § 16-50j-72(b)(2).

- 1. The proposed modifications will not result in an increase in the height of the existing tower.
- 2. The proposed modifications will include the addition of ground base equipment as depicted on the attached drawings; however, the proposed ground based cabinets will not require the extension of the site boundaries.
- 3. The proposed modifications will not increase noise levels at the facility by six decibels or more.
- 4. The additional ground based equipment will not increase radio frequency (RF) emissions at the facility to a level at or above the Federal Communications Commission (FCC) adopted safety standard.

For the foregoing reasons, Sprint respectfully submits that the proposed modifications to the above referenced telecommunications facility constitutes an exempt modification under R.C.S.A. § 16-50j-72(b)(2).
