Dear Attorney Bachman:

The Connecticut Siting Council (Council) hereby acknowledges your notice to modify this existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies with the following conditions:

- Prior to T-Mobile's antenna installation, the proposed tower modifications s hall be installed in accordance with the Structural Modification Report prepared by B+T Group, dated June 13, 2019 and s tamped and signed by Scott S. Vance;
- Within 45 days following the completion of equipment installation, Verizon shall provide documentation certified by a Professional Engineer that its installation complied with the recommendation s of the Structural Modification Report;
- Any deviation from the proposed modification as specified in this notice and supporting materials wi.th the Council shall render this acknowledgement invalid;
- 4. Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
- Within 45 days after completion of construction, the Council s hall be notified in writing that construction has been completed;
- 5. An y nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by T-Mobile shall be removed within 60 days of the date the antenna ceased to function;
- 6. The validity of this action s hall expire one year from the date of this letter; and
- 7. The applicant may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council no less than 60 days prior to the expiration.

The attached PE Closeout Letter dated December 1, 2020 provides evidence of compliance with the conditions outlined by the Council. In addition, T-Mobile hereby notifies the Council that construction of the acknowledged modifications were complete as of October 2, 2020.
