TS-T-MOBILE-042-180309 - T-Mobile Northeast LLC request for an order to approve tower sharing at an existing telecommunications facility located at 151 Young Street, East Hampton, Connecticut.

Dear Ms. Comwall:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on March 9, 2018. On March 20, 2018, the Council issued a letter of incompletion due to the status of the dish antenna's function. On March 27, 2018, Crown Castle responded to the notice of incompletion.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Upon further staff review, this tower share request remains incomplete at this time. Staff has subsequently identified a discrepancy between site plan sheet numbers C-4, C-8 and G-1 dated February 22, 2018 which reference a Perfect Vision round platform mount compared to a four-sided Valmont mount listed in the Structural Analysis Report dated January 15, 2018.

Therefore, the tower share remains incomplete at this time. The Council recommends that Crown Castle provide a Structural Analysis Report which references the Perfect Vision round platform mount consistent with site plan sheet numbers C-4, C-8 and G-1 dated February 22, 2018 and not to exceed 100 percent of the structure's post construction rating prepared by a professional engineer duly licensed in the State of Connecticut on or before May 4, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 4, 2018.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
