RE: **EM-SPRINT-047-170920** – Sprint notice of intent to modify an existing telecommunications facility located at 50 Plantation Road, East Windsor, Connecticut.

Dear Mr. Perkowski:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on September 20, 2017.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified the following deficiencies:

1. The cover letter states Sprint would replace three antennas and install six remote radio heads that is contrary to the structural analysis report and construction drawings which propose three new antennas and three new remote radio heads.
2. The construction drawings are dated March 4, 2014.
3. The structural analysis report is dated April 22, 2014. This does not account for modifications to the facility since 2014 nor the 2016 Connecticut State Building Code and ANSI/TIA/EIA-222 Revision G standard.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Airosmith Development provide one copy of a Structural Analysis Report and construction drawings, that are stamped and signed by a Professional Engineer duly licensed in the State of Connecticut, to the Council referencing the accurate existing and proposed equipment, the 2016 Connecticut State Building Code and ANSI/TIA/EIA-222 Revision G standard (if applicable) on or before October 27, 2017. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to October 27, 2017.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
