RE: **EM-AT&T-049-230112** - AT&T notice of intent to modify an existing telecommunications facility located at 188 Moody Road, Enfield, Connecticut.

#### Dear Catherine Conklin:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on January 12, 2023. On January 20, 2023, the Council issued a letter (enclosed) stating that the request for exempt modification was incomplete because the electronic copy of the exempt modification request did not include the Construction Drawings (CD) referenced within the cover letter as Attachment 1. The Council recommended that AT&T provide an electronic copy of the CD that should be included in Attachment 1 of the exempt modification request on or before February 14, 2023.

On January 20, 2023, the Council received an electronic mail with a copy of the CD dated December 27, 2022. However, the CD provided, cites the 2015 International Building Code (IBC). The State of Connecticut has adopted the 2022 Connecticut State Building Code (CSBC) effective October 1, 2022, which references the 2021 IBC.

Therefore, the exempt modification request remains incomplete at this time. The Council recommends that AT&T provide updated CDs that comports with the current 2022 CSBC on or before February 14, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to February 14, 2023.

Please provide an electronic version and one hard copy of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on January 12, 2023.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the request. The electronic copy of the exempt modification request does not include the construction plans referenced within the cover letter as Attachment 1.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that AT&T provide an electronic copy of the construction plans that should be included in Attachment 1 of the exempt modification request on or before February 14, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to February 14, 2023. Please provide an electronic version of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
