Dear Mr. Barbadora:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on August 1, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the filing due to lack of notice. The property card submitted in the above filing indicates J Fernandes Properties, LLC as the current property owner, however proof of notice shows that a copy of the filing was sent to a Ranjan and Moitrayee Ghosh. The Council issued a memorandum on June 22, 2017 to entities requesting exempt modifications requiring a copy of the entire notice and attachments be physically mailed to the chief elected official of the host municipality and the underlying property owner and proof of such mailing shall be submitted to the Council with the request for exempt modification. See attached.

The above referenced request for exempt modification lacks proof that the entire request for exempt modification was physically mailed to the underlying property owner.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Transcend Wireless provide proof of proper notice of this exempt modification request to the underlying property owner, on or before August 17, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to August 17, 2018.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).


