The installation is within general conformance to the modification drawings and no exception is taken to the installation as detailed in this report.

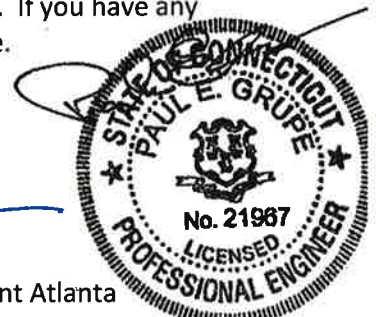
