The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on November 21, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the Radio Frequency Emissions Analysis (RF) Report provided with the request. The RF Report provided is dated June 18, 2018. The Council had acknowledged a request for exempt modification from Verizon for the same facility on June 6, 2018 and the above referenced RF Report does not account for Verizon's most current power density data. Please see Verizon's exempt modification request for this facility, which may be found on the Council's website under the Decisions page in Greenwich under the filing number EM-VER-057-180606 or by following the link:

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Cherundolo Consulting provide an updated RF Report for the facility that includes the most current power density data for Verizon and other entities that are located at this facility on or before January 4, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to January 4, 2019.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
