- Installation shall be performed in accordance with the structural analysis report prepared by Atlantis Group, Inc. dated February 17, 2015 and stamped by Dmitry V. Albul;
- Within 45 days following completion of the equipment installation, T-Mobile shall provide documentation certified by a Professional Engineer that its installation complied with the **recommendations of the structural analysis**;
- Any deviation from the proposed modification as specified in this notice and supporting materials with the Council shall render this acknowledgement invalid;
- Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
- Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
- Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by T-Mobile shall be removed within 60 days of the date the antenna ceased to function;
- The validity of this action shall expire one year from the date of this letter; and
- The applicant may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The attached PE Closeout Letter dated September 30, 2016 provides evidence of compliance with the conditions outlined by the Council.

In addition, T-Mobile hereby notifies the Council that construction of the acknowledged modifications were complete as of November 20, 2015.

Paul J. Ford and Company has completed a post-construction review per the requirements of the Connecticut Siting Council. The purpose of the letter is to verify that the proposed antennas listed in Table 1 (next page) have been installed. The review is consistent with the guidelines as stated in the 2005 Connecticut Building Code and the TIA/EIA-222-F Structural Standards for Steel Antenna Towers and Antenna Supporting Structures using a fastest mile wind speed of 85 mph with no ice, 74 mph with 1/2 inch ice thickness and 50 mph under service loads.

Based on a comparison of the verified proposed loading (shown Table 1 & 2) versus the previous analysis loads (including wind speeds) from Atlantis Group [dated February, 2015] we have determined that loading is similar and should not change the analysis results.

Based upon a review of the photos provided, it appears that the antennas and equipment listed in Table 1 have been installed per the construction drawings.
