Notice of Compliance with Conditions and Construction Completion

Dear Attorney Bachman:

The Connecticut Siting Council (Council) hereby acknowledges your notice to modify this existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies with the following conditions:

1. Prior to T-Mobile's antenna installation, the proposed antenna mounts shall be installed in accordance with the Mount Analysis prepared by EFI Global, Inc., dated June 23, 2020 and stamped and signed by Ahmet Colakoglu;
2. Within 45 days following completion of equipment installation, T-Mobile shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis;
3. Any deviation from the proposed modification as specified in this notice and supporting materials with the Council shall render this acknowledgement invalid;
4. Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
5. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
6. Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by T-Mobile shall be removed within 60 days of the date the antenna ceased to function;
7. The validity of this action shall expire one year from the date of this letter; and
8. The applicant may file a request for an extension of time beyond the one-year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The attached PE Closeout Letter dated July 13, 2021 provides evidence of compliance with the conditions outlined by the Council. In addition, T-Mobile hereby notifies the Council that construction of the acknowledged modifications were complete as of March 21, 2021.

Representatives of EFI Global, Inc. (EFI) performed a review of documentation provided by the general contractor after recent construction and equipment addition to the existing T-Mobile telecommunications facility at the above referenced address.

The review was undertaken to determine if the construction was in substantial conformance with the following documentation, along with the requirements of the 2018 Connecticut State Building Code and ANSI/TIA-222-G:

- Mount Structural Analysis Report prepared by EFI Global, Inc., dated 6/23/2020.

The following documentation was provided to EFI for review:

- Photographs prepared by General Contractor, dated 3/27/2021.

Based on the provided documentation, the following observations were made, and found to be acceptable:

- Each sector mount includes four (4) pipe mounts rather than the designated five (5) pipe mounts.

Based on my knowledge, information, and belief, the T-Mobile installation substantially conforms to the above referenced documentation. All deviations from the approved plans do not endanger the intended occupancy of the facility and equipment substitutions are approved as equivalent to the original specifications.

Therefore, EFI **approves** the construction of the T-Mobile Installation.
