The following are the basis for substantiating compliance with the equipment modification documents prepared by All-Points Technology Corporation, P.C.:

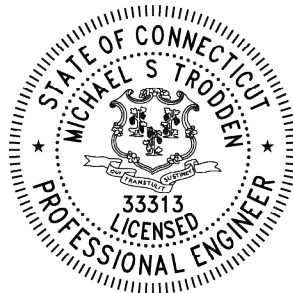
