
We are providing this letter of compliance with regard to the above referenced project. The following are the basis for substantiating compliance with this modification:

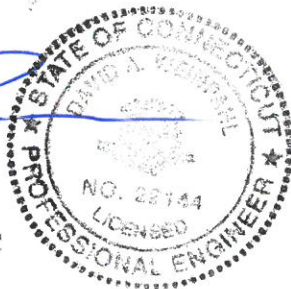
