Paul J. Ford and Company is pleased to submit this "Structural Opinion Letter" for the structural integrity of the aforementioned tower. The purpose of the opinion letter is to determine the suitability of the tower with the proposed and existing loading as specified in Tables 1 & 2 on the next two pages. The opinion is consistent with the guidelines as stated in the 2005 Connecticut Building Code and the TIA/EIA-222-F Structural Standards for Steel Antenna Towers and Antenna Supporting Structures using a fastest mile wind speed of 85 mph with no ice, 37.6 mph with 0.75 inch ice thickness and 50 mph under service loads.

Based on a comparison of the verified proposed loading (shown Table 1 & 2) versus the previous analysis loads (including wind speeds) from Crown Castle (job number 711991, dated February 25, 2014) we have determined that loading is similar and should not change the opinions concluded by others.

Based upon a review of the photos provided, it appears that the antennas and equipment listed in Table 1 have been installed.
