
We are providing this "Tower Modification Certification" with regard to the structural components at the above referenced project.

The following are the basis for substantiating compliance with the tower modification documents prepared by Tower Engineering Professionals (TEP Project Number: 51819.13672):

- Review of the Tower Engineering Professionals Structural Analysis dated 01/27/2014.
- Review of the Tower Engineering Professionals Modification Drawings T-1,N-1 thru N-4, and S-1 thru S-8 dated 01/27/2014.
- Review of the Tower Engineering Professionals Modification Inspection Report dated 07/01/2014.
- Review of the Centek Engineering Final Report of Special Inspections dated 09/17/2014.
- Field observations by Centek Engineering personnel on 09/15/2014 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the structural analysis report prepared by Tower Engineering Professionals on 01/27/2014.

The modification design prepared by Tower Engineering Professionals demonstrates the tower will not exceed 100 percent of the post construction structural rating.
