Good afternoon, Tom.

I hope all is well.

We received the attached request for an exempt modification for the Moose Hill Road tower, which certificate was transferred to Bay Communications in 2013. The D&M Plan for this facility was approved in April of this year and a commencement of construction letter was submitted on June 9, 2015. The D&M Plan staff report references that T-Mobile may install an additional 3 antennas at a later date to meet service needs. A copy of the staff report is attached for your convenience.

The request for an exempt modification from T-Mobile should have been submitted as a D&M Plan revision rather than a request for an exempt modification as the tower is not fully constructed or operational at this time. An extension for construction was granted to October 8, 2015. We would be amenable to processing the request for an exempt modification as a D&M Plan revision upon receipt of a written request from the Certificate Holder.
