Request for Extension

Dear Ms. Bachman:

The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) received acknowledgement from the Connecticut Siting Council ("Council") on July 30, 2019 that Eversource's proposed modification of the Stepstone Substation would comply with the exempt modification criteria in Section 16-50j-57 of the Regulations of Connecticut State Agencies. Eversource is requesting an extension of the deadline for completing the work activities based on the following condition:

• The petitioner may file a request for an extension of time beyond the one-year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The North Bloomfield Substation project (EM-EVER-011-190313e) required an emergency transformer replacement which utilized the transformer destined for the Stepstone Substation project. As a result, Eversource hereby requests that the one year deadline to complete the activities at Stepstone Substation be extended to June 28, 2020.
