Based on the photographs provided; As Built drawings certified by R. Siegel of Eastern Communications, Inc., dated April 1, 2021; and the construction drawings by B+T Group dated July 19, 2019; I hereby certify that to the best of my knowledge, information, and belief all constructed improvements are in substantial compliance with the permitted construction drawings approved by the Town of Hamden (last revised July 19, 2019) and that said improvements meet the intent of the applicable Codes listed on said drawings (e.g., 2018 CT SBC and NEC 2017).

Furthermore, it is hereby noted that, at the direction of the Client, the Contractor deviated from the approved construction drawings with the installation of differing antenna and radio models and cabling.
