RE: **TS-DISH-069-220927** – Dish Wireless, LLC request for an order to approve tower sharing at an existing telecommunications facility located at 1375 North Road, Killingly, Connecticut.

Dear Jack Andrews:

At a public meeting held on October 13, 2022, the Connecticut Siting Council (Council) ruled that the shared use of this existing tower site is technically, legally, environmentally, and economically feasible and meets public safety concerns, and therefore, in compliance with General Statutes § 16-50aa, the Council has ordered the shared use of this facility to avoid the unnecessary proliferation of tower structures with the following conditions:

- 1. Approval of any changes be delegated to Council staff;
- 2. Prior to the commencement of construction, DISH shall provide a copy of the Structural Analysis referencing the Connecticut State Building Code effective October 1, 2022;
- 3. Install a caution sign and NOC information sign 10-feet above ground level at the base of the tower consistent with the Radio Frequency Electromagnetic Energy Report prepared by EBI Consulting, dated September 6, 2022 and stamped and signed by Michael McGuire;
- 4. Any deviation from the proposed installation as specified in the original tower share request and supporting materials with the Council shall render this decision invalid;
- 5. Any material changes to the proposed installation as specified in the original tower share request and supporting materials filed with the Council shall require an explicit request for modification to the Council pursuant to Connecticut General Statutes § 16-50aa, including all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65;
- 6. The Council shall be notified in writing at least two weeks prior to the commencement of site construction activities;
- 7. Not less than 45 days after completion of the proposed installation, the Council shall be notified in writing that the installation has been completed;

- 8. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
- 9. Any nonfunctioning antenna and associated antenna mounting equipment, or other equipment at this facility owned and operated by Dish Wireless, LLC shall be removed within 60 days of the date the antenna or equipment ceased to function;
- 10. The validity of this action shall expire one year from the date of this letter; and
- 11. The applicant may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and applies only to this request for tower sharing dated August 20, 2022. This facility has been carefully modeled to ensure that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies now used on this tower. Any deviation from the approved tower sharing request is enforceable under the provisions of Connecticut General Statutes § 16-50u.

The proposed shared use is to be implemented as specified in your letter dated August 20, 2022, including the placement of all necessary equipment and shelters within the tower compound.

Please be advised that the validity of this action shall expire one year from the date of this letter.
