**RE: TS-ATT-069-230331** – AT&T request for an order to approve tower sharing at an existing telecommunications facility located at 812 Providence Pike, Killingly, Connecticut.

Dear Attorney Patrick:

The Connecticut Siting Council (Council) received a tower share request for the above-referenced facility on March 31, 2023.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, “no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies...”

Staff has reviewed this tower share request for completeness and has identified a deficiency in the Mount Analysis dated August 2, 2022 provided with the filing. The above-referenced documents cites the 2018 Connecticut State Building Code (CSBC); however, the State of Connecticut has adopted the 2022 CSBC effective October 1, 2022.

Therefore, the tower share request is incomplete at this time. The Council recommends that AT&T provide an updated Mount Analysis that comports with the current 2022 CSBC on or before May 19, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 19, 2023. **Please provide an electronic version and one hard copy of the requested information for the incomplete tower share filing to be rendered complete and processed. Please include the Council’s tower share identification number referenced above with the submittal.**

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
