To the best of my information, knowledge and belief, the Special Inspections required for this project, and itemized in the *Statement of Special Inspections* submitted for permit, have been performed and all discovered discrepancies have been reported and resolved.

Representatives of Centerline performed the Final Inspections after the construction of the telecommunications facility at the above-referenced address. The Final Inspection was performed on June 26, 2024.

Based on my knowledge, information and belief, the Verizon Installation substantially conforms to the approved plans, IBC 2021, 2022 CT State Building Code, Structural Standards for Antenna Supporting Structures and Antennas (ANSI/TIA-222-H), and the following:

1. Final Construction Drawings dated 03/25/24 by Centerline Communications.
2. As-Built Redlined Construction Drawings dated 06/19/24 by NEC Group, LLC.
