Item#1 of the attached CSC decision states construction activities shall be conducted between November 1 and April 1 due to wood turtles. Verizon does have their building permit, issued 2/9/2022, but feels because of the extent of the work, scheduling and materials the construction may not be completed until 4/15 to 4/25.
