Dear Ms. Bachman:

Sprint Spectrum L.P., a Delaware limited partnership (“Sprint”) currently maintains a wireless telecommunications facility at the above referenced site/address. Sprint currently maintains an existing LPG generator and propane tank.

In an effort to further enhance Sprint’s network reliability, Sprint intends to modify its facility by removing the existing generator and installing a new Generac QT-27-VP vapor generator in the existing place. Removing the existing propane tank and installing a new 250 gallon ASME tank in its current location. The replacement project will incorporate the replacement of all piping, valves, and regulators per AHJ compliance. Install of a new ASCO ATS switch on the dinrail behind the PPC and telco. (See Facility Compound Plan attached).

Please accept this letter as notification pursuant to R.C.S.A. Section 16-50j-72(b)2 of the Regulations of Connecticut State Agencies. A notice will be sent to the chief elected official of the municipality of the site in writing prior to its intent to begin the equipment replacement project.

Sprint’s Proposed Wireless Modification Constitutes an “Exempt Modification”

The proposed modification to the above mentioned Facility constitutes an exempt modification of an existing facility provided for in R.C.S.A. Section 16-50j-73 and Council regulations pursuant thereto.



- 1) The proposed modification will not result in an increase in the height of the existing tower.
- 2) The generator and tank will remain entirely within the limits of the leased area. Therefore, the modifications will not require the extension of the boundary.
- 3) The proposed modification does not increase the noise levels at the boundary to six (6) decibels or more under normal conditions. Proposed modification is only used during emergency power failure.
- 4) The installation of a new generator and tank will not change, in any way, radio frequency (RF) emissions at the facility.
- 5) The facility has received all municipal zoning approvals and building permits as noted under the Regs., Conn. State Agencies Section 16-50j-72))

For all the foregoing reasons, Sprint Spectrum, L.P. respectfully submits that the proposed modifications to the above-referenced telecommunications facility constitutes an exempt modification under R.C.S.A. Section 16-50j-72.
