On July 9, 2018, the Siting Council acknowledged receipt of Cellco’s notice of intent to modify its existing telecommunications facility at 21 Acorn Road in Branford, Connecticut. Cellco’s modifications involved the replacement of antennas and remote radio heads.

We are providing this letter of compliance with regard to the above referenced project. The following are the basis for substantiating compliance with this modification:

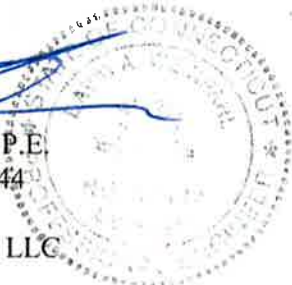
