Dear Mayor Vetro:

The Connecticut Siting Council (Council) is in receipt of the Town of Milford's correspondence dated August 8, 2018 concerning the above-referenced request for a temporary facility. Thank you for taking the time to provide the Council with your comments.

Before making a final decision on a request for an exempt modification, the Council carefully considers the proposal in accordance with the required feasibility criteria under 16-50j-72(d) of the Regulations of Connecticut State Agencies for temporary cellular service for events of statewide significance. Entities requesting an exempt modification for a temporary facility must demonstrate that the proposal is consistent with the Exempt Modification criteria for temporary facilities including, but not limited to, that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies to be used on this temporary facility and that noise levels do not exceed state criteria.

Thank you for your interest and concern with this matter.

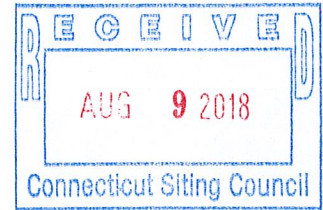
